## SIDEWALK SAFETY

The U.S. may be seeing one of the warmest winters on record, but we're never more than a cold front away from another snowfall. To that end, Arlington County reminds residents that they're required by county ordinance to keep the sidewalks in front of their homes free of snow and ice within 24 or 36 hours of a snow storm.

To wit, all property owners are required to remove snow and ice from public sidewalks adjacent to their property:

- Must be removed from the entire width of the sidewalk up to 3 feet wide (to accommodate wheelchairs, strollers, and adults with children in hand).
- Must be removed within 24 hours after the snow stops falling when accumulations are less than 6 inches, and within 36 hours when 6 or more inches of snow accumulate (as measured at National Airport, per National Weather Service). If another snow event occurs, the clock will reset to the end of the most recent snowfall. The official snow ending time will be posted at [www.arlingtonva.us/portals/topics/TopicsWeatherWinter.aspx](http://www.arlingtonva.us/portals/topics/TopicsWeatherWinter.aspx)
- Noncompliance could result in a civil penalty of \$50 for sidewalks less than 200 linear feet in length, or \$100 for sidewalks longer than 200 feet.
- The County may remove the snow or ice on sidewalks around private property when the owner fails to comply within the designated time period, and charge the cost to the owner.
- Private owners may not deposit snow or ice from private property onto public property, including streets & sidewalks. Such action may result in a class 4 (criminal) misdemeanor and fine of \$250.

## NCAC UPDATE

The Neighborhood Conservation Advisory Committee approved the Highland/Ivy/9th street lights project at its meeting last December. The County Board is scheduled to decide whether to fund the project at its Feb. 23rd meeting. County staff say that it's almost certain that the Board will approve the funding and the staff's 'initial estimate' is that construction will begin one year later.

AHCA can have two Neighborhood Conservation (NC) projects in the funding queue, and we now just have one - the 5th St. street lights project.

## LIGHT UP THE NIGHT

Many of the Arlington Heights streetlights have already been converted to LED lighting, with a few more scheduled for the upgrade in the near future:

\* A few lights on S. Old Glebe Rd. new S. 2nd Street

- \* S. Hudson St. (Arl. Blvd to 2nd St S)
- \* S. Garfield St. (6th St. S. to 7th St. S.)
- \* S. Ivy cul de sac (at 7th St S)
- \* 7th Street S. (Glebe to Walter Reed)
- \* S. Irving St (7th Street S. to 9th Street S.)
- \* 9th Rd. S. at Walter Reed Dr.
- \* S. Glebe Road - only a few lights near Col. Pike

The county anticipates that these conversions will occur between February-April, barring any unforeseen issues. All future conversions of LED streetlights will include adding the eyebrows on the side of the lights adjacent to private properties. Also, all of the converted LED streetlights in neighborhoods are utilizing dimming technology which occurs gradually as night progresses. For previous installations, the county is installing eyebrows on a case by case basis after receiving a request from the adjacent property owner. ## NOISY NEIGHBORS: HOW LOUD IS TOO LOUD?

The county wants to know and is expected to hold a public hearing during the first quarter of 2013 (exact date to be announced) to vote on the first comprehensive overhaul of the County's Noise Control Ordinance.

Proposed changes include:

- Civil penalties on violators after a warning is issued or posted on the premises.
- Criminal penalties for violations would increase from \$25 to not less than \$100 or more than

\$2,500 upon conviction.

- New methods to determine a noise violation that is above grade, or that occurs within multi-unit buildings.
- Clarity on the agencies and scope of work that are allowed exemptions to complete emergency repairs.

• Enhanced prohibited acts to address issues such as loud music and animal noises.

## ARLINGTON COUNTY AND FEDERAL GOVERNMENT APPROVE FRAMEWORK FOR NAVY ANNEX LAND EXCHANGE

On January 10, 2013, the Arlington County Board unanimously approved a Memorandum of Understanding (MOU) with the United States Department of the Army that establishes a framework for a future land exchange agreement between the two parties at the Navy Annex site.

The MOU outlines the key objectives for both parties and the framework for a future land exchange. Under the agreement, the Army would receive all property north of a realigned Columbia Pike in exchange for providing the County with land south of a realigned Columbia Pike.

The existing Southgate Road would be realigned to the western edge of the Navy Annex site to maintain appropriate access to Joint Base Myer-Henderson Hall, while directly linking the Navy Annex site to the existing Arlington National Cemetery grounds. Engineering and design work must be completed to deter-

mine the exact location for a realigned Columbia Pike and the parties must work out the exact acreage and parcels to be exchanged.

“Arlington National Cemetery is sacred ground for our community, our region and certainly, our nation,” Board Chairman Walter Tejada said. “This MOU paves the way for an agreement that will allow us to support their expansion goals. At the same time, it enables us to meet our goals: preserving and displaying Arlington County’s history and heritage by establishing an Arlington Heritage Center and Freedman’s Village Museum, and fulfilling our transportation and economic development vision for Columbia Pike.”

The County Board action was necessitated by the decision of the Department of Defense last year to terminate the previous land exchange agreement, which would have provided the County with 4.23 acres of land on the Navy Annex Property north of Columbia Pike in exchange for providing DOD with an equivalent acreage of the Southgate Road right-of-way.



## COLUMBIA PIKE UNDERGROUNDING AND STREET IMPROVEMENTS

Construction continues for the Utility Undergrounding and Street Improvement project, located between S. Wakefield Street and S. Four Mile Run Drive. The County's contractor is wrapping the installation of the Dominion Virginia Power, Verizon, and Comcast duct banks. (This is a construction method designed to consolidate wiring into centralized underground paths). These utility companies will then begin pulling lines and making the necessary connections to allow the removal of the existing utility poles along this segment of the Pike.

The street improvement phase of this project, which includes installation of storm drain, wider sidewalk, street trees, and street lights, will coincide with the wiring connections. Construction for the street improvements will require lane closures with at least one westbound and one eastbound lane open at all times. Crews may perform some of this work during evening hours to minimize impact to businesses and motorists during the day. Residents can expect some construction noise associated with this work. County staff appreciates your patience during this time! Businesses located along this segment of Columbia Pike remain open during construction and owners greatly appreciate the community's continuous support.

residential and commercial neighborhoods where people unite to form a caring, learning, participating, sustainable community in which each person is important."


